## Child Care Toy Cleaning from Sanitation

- Toys (and any mouth contact surface) in the infant and toddler rooms shall be cleaned and sanitized after each use and when visibly dirty.
- □ Anything that is placed in a child's mouth must be cleaned and sanitized between children.



- □ A separate "dirty" toy bin is recommended.
- All dirty toys shall be scrubbed with warm soapy water to remove contamination, rinsed in clean water, and then submerged in a sanitizing solution (such as 50-200 PPM chlorine), for at least 2 minutes (or accordance with the sanitizer instructions). Toys should then be removed from the chlorine solution and air dried.
- □ Plush toys can be washed in a clothes washing machine and mechanically dried.
- □ Hard plastic toys may be washed and rinsed in a dish washing machine, the kitchen sink, or in a food preparation hand wash sink (after a change of use).
- □ Toys, items, and surfaces not designed to be submerged shall be washed and rinsed in place, sprayed with a sanitizing solution, and allowed to air dry.
