# Cabarrus Partnership for Children Receives Cabarrus Head Start Grant

The Office of Head Start recently announced The Cabarrus County Partnership for Children (Partnership) was awarded the Cabarrus County Head Start grant effective July 1, 2015 – June 30, 2020. The Partnership is working collaboratively with Cabarrus County Schools and other community partners to implement the new Head Start program for children and families in Cabarrus County. The Cabarrus Partnership for Children Head Start Program will serve 170 children in 10 classrooms at the Long Preschool and the Lockhart Early Learning Center.


#### **Building Healthy Lifestyles**


State legislation requires the Partnership to provide at least 15% in matching funds. The Partnership, along with our community partners, raised 25%, exceeding the required amount.
